THE FINANCE DIRECTOR AND CLINICAL DIRECTOR SALARIES ARE PROPOSED BY THE EXECUTIVE DIRECTOR AS PART OF THE OVERALL BUDGET PROCESS EACH YEAR. THE EXECUTIVE DIRECTOR REVIEWS COMPENSATION SURVEYS FROM THE COLORADO NONPROFIT ASSOCIATION AND OTHER RELEVANT DATA SOURCES AND BASES THE RECOMMENDATION ON COMPARABLE ORGANIZATION BUDGET, FOCUS OF SERVICE, REGION, LEVEL OF EXPERIENCE, AND NUMBER OF YEARS EXPERIENCE IN THE NON-PROFIT SECTOR. THE FINANCE COMMITTEE OF THE BOARD OF DIRECTORS REVIEWS OVERALL SALARY RECOMENDATIONS, INCLUDING THAT OF THE FINANCE DIRECTOR, PRIOR TO RECOMMENDING APPROVAL OF THE ORGANIZATIONAL BUDGET.
