## **Consent for Treatment with Hyaluronic Acid Injectable Products**

(Juvederm Ultra/Ultra Plus/Voluma XC, Restylane Silk/Perlane-L, Belotero Balance)

The hyaluronic acid products (mentioned above) are sterile gels consisting of non-animal stabilized hyaluronic acid for injection into the skin to correct facial lines, wrinkles and folds, for lip enhancement and for shaping the facial contours. The uses of hyaluronic acid products have been explained to me by Dr. Blanchar and I have had the opportunity to have all questions answered to my satisfaction.

I have been specifically informed of some of the common injection-related reactions which might occur. These include redness, swelling, pain, itching, bruising and tenderness at the implant site. They have generally been described as mild to moderate and typically resolve spontaneously a few days after injection. Other types of reactions are rare, but include localized allergic reactions after one or more injections. These usually consisted of swelling and firmness at the implant site, sometimes affecting the surrounding tissues. Redness, tenderness and rarely acne-like formations have also been reported. These reactions have either started a few days after injection or after a delay of several weeks and have generally been described as mild to moderate and self-limiting, with an average duration of two weeks. In rare instances such reactions have persisted for several months. On very rare occasion prolonged firmness, abscess formation or grayish discoloration at the implantation sites has occurred. These reactions can develop weeks to months following the injections and may persist for several months but normally resolve with time. Rarely, the formation of a scab and sloughing (shedding) of tissue at the treatment site has been noted, which could result in a shallow scar.

Dr. Blanchar has also informed me that depending on the area treated, skin type and the injection technique the effect of treatment with hyaluronic acid products can last 6-12 months but that in some cases the duration of the effect can be shorter or even longer. Touch-up and follow-up treatment helps sustain the duration, as well as full correction.

I authorize Dr. Blanchar to disclose complete information concerning his medical findings and treatment of the undersigned, from the initial office visit until the date of the conclusion of such treatment, to those individuals who, in Dr. Blanchar's sole determination, are required to receive such information for the purpose of medical treatment, medical quality assurance and peer review.

I have answered the questions regarding my medical history to the best of my knowledge. have also been explained post procedure instructions.  I consent to being treated with hyaluronic acid products
