PRIVATE PAY FEE SCHEDULE

- **Diagnostic Interview:**
 - Performed by a MD or NP: \$415.00
 - Performed by a Psychologist or Therapist: \$300.00
- **Medication Management:**
 - 25-30 minute session: \$285.00
 - 40 minute session: \$385.00
 - Both sessions are performed by an MD or NP
- **Psychotherapeutic Session:**
 - 38-52 minute individual therapy: \$215.00
 - 52+ minutes of individual therapy: \$277.50
 - 38-52 minute family therapy: \$225.00
 - 60 minute group therapy: \$250.00
- **Phone Call with a Provider or Nurse:**
 - 1-10 minutes: \$30.00
 - Each 10-minute increment thereafter: \$40.00
 - To speak with a provider's nurse, contact the front desk at 763-559-1640 and the nurse will be in contact with patient free of charge within 24 business hours.
- **Psychological Testing:**
 - Clients are required to fill out a separate financial statement regarding insurance and payment responsibility and are billed according to that agreement for any psychological testing performed.
- **Out of Pocket Payments:**
 - A 20% discount on services (as listed above) is available to clients choosing not to use insurance and who pay in full at the time of service.
- **Other Fees**
 - Returned Checks/Debit Transactions: \$25.00
 - Records Requests:
 - 1-19 pages: \$0.25 per sheet; 20+ pages: \$0.25 per sheet + \$5.00 processing fee
 - Charges will be applied to the account of the person whose records are requested.
 - Missed or Cancelled Appointments:
 - Missed appointment (no call, no show) under any circumstances: \$70.00
 - Cancellation within 24 hours of appointment: \$70.00
 - Cancellation prior to 24 hours of appointment: None
 - Cancellations due to Winter Weather Advisory: None
 - Charges for missed appointments are not covered by your insurance and are your responsibility.
 - Subpoenas – In Person Testimony or Appearance
 - Preparation, commuting, etc.: \$250.00/hour (with a 3 hour minimum charge)
 - Court appearance: \$2000.00 one time fee
 - Subpoenas – Documentation Only
 - 1-2 hours of preparation: \$500.00 one-time fee
 - 2 or more hours of preparation: \$250.00/hour (with a 3 hour minimum charge)

**As permissible under applicable law, Plymouth Psych Group reserves the right to demand payment of these fees in advance of in-person appearance and record and/or documentation production. Plymouth Psych Group will comply with all applicable HIPAA, Minnesota Privacy Act and other regulations in responding to all subpoenas.*
