

FINANCIAL POLICY at SHAHLA RAH, MD INC.

WE WISH TO PROVIDE YOU WITH THE BEST POSSIBLE CARE, AND WE ARE PLEASED TO DISCUSS OUR PROFESSIONAL FEES WITH YOU. PLEASE ASK THE STAFF IF YOU HAVE ANY QUESTIONS ABOUT OUR FEES, FINANCIAL POLICY, OR YOUR FISCAL RESPONSIBILITY.

REQUIRED IDENTIFICATION

It is our policy to require a social security number and a copy of government-issued picture identification for record keeping purposes even if it is not the policy of your insurance carrier.

PATIENT RESPONSIBILITY for insured patients

Payment is due at the time of service for all services. We accept cash, checks, and all credit cards.

It is your responsibility to know your insurance plan and to verify coverage for other facilities recommended tests and laboratories. We will bill your insurance company, however, any co-payment, co-insurance and/or deductible are due at the time of service. Amounts collected are an estimated patient balance and may differ from what the insurance carrier ultimately pays. If insurance does not pay within 45 days, you will be responsible for the bill. Your insurance company may not cover payment for services provided by Shahla Rah, MD at a reasonable or customary rate accepted by Dr. Rah. This is the maximum amount that you can be billed for.

PREVENTATIVE AND DIAGNOSTIC CARE

If a problem is discovered and treated during a preventative visit, this will either change a preventative care visit to a diagnostic one or it may result in a charge for an additional visit and/or procedure. Be aware of your benefits for each.

LAB TEST AND OTHER CHARGES

If your visit includes lab tests, biopsies, and specialty GI tests (ex. Genova, Prometheus), etc. you will receive a separate bill from the lab. We are not responsible for any bills from labs, endoscopy or imaging centers.

ADDITIONAL FORMS

There will be a fee to complete work, disability and other patient requested forms at a rate of \$50 dollars.

MISSED APPOINTMENT

There will be a \$100 fee for new patients and a \$50 fee for current patients for failed appointments or appointments not cancelled at least 48 hours in advanced

MISSED PROCEDURES

There will be a \$150 fee for failed procedures appointments or procedures not cancelled at least 48 hours in advance.
