# 2. "It is important to consult with a health care professional before using any dietary supplement."

"Dietary supplements are regulated by the FDA as food, not as drugs. However, many dietary supplements contain ingredients that have strong biological effects which may conflict with a medicine you are taking or a medical condition you may have. Products containing hidden drugs are also sometimes falsely marketed as dietary supplements, putting consumers at even greater risk. For these reasons, it is important to consult with a health care professional before using any dietary supplement."

Poor compliance may be attributed, at least in part, to inadequate enforcement; in 2013, the FDA inspected only 416 supplement manufacturers for cGMP\* adherence, representing 10% of the estimated 4000 manufacturers covered by cGMP regulations and 2.8% of the 14,995 domestic and international dietary supplement firms registered with the FDA."

\*cGMP – Current Good Manufacturing Practice - Good manufacturing practices are the practices required in order to conform to the guidelines recommended by agencies that control the authorization and licensing of the manufacture and sale of food and beverages, cosmetics, pharmaceutical products, dietary supplements, and medical devices.

For example, rice planted in several key agricultural provinces was reported to contain excessive Cadmium, a metal commonly found in batteries, coloring, and the industrial waste from making plastic. It may cause serious kidney disease.

Irrigation water is a nightmare: Half of the country's major water bodies are polluted, as are 86 percent of city water bodies. Pollution is largely caused by the country's numerous factories, which rarely have equipment for treating pollution. Seventy to 80 percent of the country's industrial waste is directly emitted into rivers."

Even those labeled as "organic" are not safe, since **USDA organic standards place no limit on levels of heavy metal contamination for certified organic foods**.

# 8. The Journal of the American Medical Association found that dietary supplements account for half of all Class 1 drug recalls in the United States.

The research, supported by the Canadian Institutes of Health Research, showed that over a nine-year period (2004–2012), 51 percent of the U.S. Food & Drug Administration's (FDA) recalls involved dietary supplements containing unapproved ingredients or drugs. During this period, 465 products were recalled, of which 237 were dietary supplements.

### **Testing**

#### Round 1

#### Raw materials and components

We test every raw material and component. In our in-house laboratory we screen for raw material contaminants.

#### Round 2

#### **In-process testing**

In-process testing helps ensure the correct amount of ingredients are used in our formulations, and we stringently check for any bottle, label, or capsule defects throughout the manufacturing process.

#### Round 3

#### Finished product testing

Before being released for sale, finished products are tested to confirm the identity, potency, and purity of the ingredients, and to confirm that no microbiological contamination occurred during manufacturing.

#### **Round 4**

#### Stability testing

We test product stability to confirm each product will meet its label claims up to the product's expiration date.
