

PRIVACY STATEMENT

Denali Healthcare Specialists (the “Company,” “we”) is committed to protecting your privacy and maintaining the confidentiality and security of your personal information. This Privacy Statement applies to Denali Healthcare Specialists’ website and governs data collection and use. By using this website, you consent to practices described in this Statement.

COLLECTION OF PERSONAL INFORMATION

Denali Healthcare Specialists does not collect information that would personally identify you unless you choose to provide it. If you choose to provide us with personal information by sending an email or by filling out a form with personal information and submitting it through our website, we will use that information to respond to your message or inquiry.

Denali Healthcare Specialists collects personally identifiable information, such as your e-mail address, name, address and telephone number, as well as anonymous demographic information, which is not unique to you, such as your ZIP code, age, gender, preferences, interests and favorites. There is also information about your computer hardware and software that is automatically collected by this website. This information can include your IP address, browser type, domain names, access times and referring website addresses. This information is used for the operation of the service, to maintain quality of the service, and to provide general statistics regarding use of this website.

Please keep in mind that if you directly disclose personally identifiable information or personally sensitive data through public message boards, this information may be collected and used by others. USE OF PERSONAL INFORMATION

Denali Healthcare Specialists uses your personal information to deliver services to you that you have requested, provide customer support, and operate its website. We may use your personal information to send you email or postal mail on other products or services that we, or our affiliates, offer and to conduct research regarding your opinion of current services or potentially new services that we may provide in the future.

We may also share data with trusted third parties to help us perform statistical analysis about our visitors, traffic patterns, and how users navigate our website. The data reflect site-usage patterns gathered during visits to our website, but they do not contain behavioral or identifying information about any individual. All such third parties are prohibited from using your personal information except to provide these services and are required to maintain the confidentiality of your information.

Denali Healthcare Specialists’ website uses "cookies" to help us personalize your online experience. A cookie is a text file that is placed on your hard disk in order to collect information about your activities on the website. Cookies cannot be used to run programs or deliver viruses to your computer. Cookies are uniquely assigned to you, and can only be read by a web server in the domain that issued the cookie to you.

Denali Healthcare Specialists will not give, share, sell, or transfer any personally identifiable information that we receive from you to any party outside of the Company unless permitted or required by law. We do not use or disclose sensitive personal information, such as race, religion, or political affiliations, without your explicit consent. We do not sell, rent or lease customer lists to third parties.

SECURITY OF PERSONAL INFORMATION

Denali Healthcare Specialists secures your personal information from unauthorized access, use, or disclosure by using reasonable security measures to protect the confidentiality of personal information under our control. We secure the personally identifiable information on computer servers in a controlled, secure environment. When personal information is transmitted to other websites, it is protected through the use of encryption, such as the Secure Socket Layer (SSL) protocol.

Denali Healthcare Specialists uses third-party vendors and hosting partners to provide the necessary hardware, software, networking, storage, printing, customer service tools, and related technology to run services. If we provide personal information to third parties, we only provide the personal information needed to deliver the service. They are required to maintain high standards of confidentiality and security when using personal information and are explicitly prohibited from using that information for any other purpose.

Although we have taken reasonable steps to ensure the integrity and confidentiality of your personal information, you should understand that electronic transmissions via the Internet are not necessarily secure from interception.
