SERVICES ARE AVAILABLE AT CLINICS IN LONGMONT AND BOULDER, CO. WOMEN'S HEALTH ASSURES THAT ALL PATIENTS CAN RECEIVE THE HEALTH CARE THEY NEED REGARDLESS OF INCOME OR INSURANCE COVERAGE.
