Privacy Statement

We commit to protect the information you have provided under the Data Protection Act 1998. The following private policy discloses the practices used by Empower Medical Center. The following policy only applies to the collected information listed as followed:

- Other information gathered from contact form

In no way will we solicit your information to outside sources other than the website (health practitioner) you are submitting the information to.

Information Collected

Empower Medical Center owns the rights to the information being collected through the contact forms and we only use it for its intended purpose. When you fill out your information for appointment scheduling, contact requests, or free consultations we will not sell or rent this information to any third party vendor. Instead, when you fill out the contact form you opt-in to the following:

Unless requested of us not to contact you further, we have the ability to contact you via email regarding new products, services, or changes to our policies.

Registration

The purpose of our website(s) is to collect information pertaining to the requested information in the contact form. By filling out the contact form, users are asked to provide contact information such as: email, name, phone, and best time to reach you. The data collected is solely used for the purpose of connect with the user requesting information about the product or service.

Confidentiality

Under the Data Protection Act 1998, records are regarded as confidential and will not be divulged to any third party. Website visitors have the right to request copies of data collected on the site. Employees are only granted access to your information for areas in (billing, or customer service related tasks).
